## Mental health services crucial to the community

To the Voters of Conway:

This year you will be asked to vote to approve a petitioned warrant article in the amount of \$10,115 to support Northern Human Services — The Mental Health Center. This money will be used to provide mental health evaluation and short term treatment to Conway residents who are in emotional crisis and cannot pay the full cost of services. In 2013, the number of uninsured Conway residents seen at The Mental Health Center increased 57 percent from 164 last year to 286 this year. In spite of this dramatic increase in demand, our request for funding remains level at \$10,115.

Town supported mental health services are not about "optional' counseling. We intervene with people who are in crisis and could be a danger to themselves and/or to others if left untreated. We provide this service 24/7. A master's level clinician is on-call at all times, backed up by a board certified psychiatrist. These are professional services that are costly to provide, but crucial to the community. We are all aware of some of the tragic incidents in the past few years that have resulted from untreated mental illness. Please feel free to ask the Conway Police Department or Memorial Hospital about our responsiveness and the importance of having a locally available source of evaluation and treatment.

Northern Human Services is supported by every town in our Carroll County service area. We are not a state agency and we receive no state or federal funds to assist us in providing services on our sliding fee scale. Money appropriated by Conway voters will be used in Conway. ## Is Eaton next to adopt resolution corporate influence

Is Eaton next?

A year ago the citizens of Conway passed a non-binding resolution having to do with the influence of corporate and other moneyed interests on the political process and the corrosive effect it has on our constitutional guarantee that our government be dependent on the people alone.

A year later finds over 50 towns and cities in New Hampshire with similar resolutions on the warrant for 2014. Some communities noticed the Conway initiative and the resulting groundswell spread quickly indicating the readiness to deal with this issue.

The Newmarket Town Council recently voted unanimously to back a similar resolution. "New Hampshire has been flooded with outside money from powerful special interests on both the left and the right since the 2010 Citizens United decision." said Ellen Read, Newmarket voter. She points out "For example, in the 2012 New Hampshire gubernatorial race, estimates show that outside groups spent \$19 million (almost five times what the candidates spent). In a democracy, you shouldn't need money to have a voice in your own government."

Nationwide at least 17 states have taken action by sending similar resolutions to the Congress asking for action and more are imminent.

The Carroll County towns of Eaton (Article 15) and Wakefield have resolutions on their warrants. Dick Pollock

## Changing the descriptions of political events

Have you noticed the Republican's ability to change descriptions of political events by substituting different words like "death taxes" for the previously called inheritance tax. Most Republicans, against any program to help the poor, describe the increase in spending as "running a deficit and borrowing money from China." In truth, the Chinese only buy about 10 percent of our Treasury Bonds.
